
# MATERIALS FOR ELECTION OFFICES

#### **VOTING ASSISTANCE GUIDE COORDINATION**

The Guide is a compilation of absentee voting regulations, laws, deadlines and procedures across all U.S. states, territories, as well as the District of Columbia. As the primary source of state absentee voting information for citizens covered by UOCAVA, the Guide continues to be a critical resource in hardcopy and on FVAP.gov for our Voting Assistance Officers when assisting voters to complete the required forms and find their contact information for their election office. The Guide coordination process will be beginning in March and as in previous years, we will work with the state election offices through three stages of coordination, each step requiring different, crucial, and timely information for voters. Be sure to reach out to us with any legislative or regulatory changes that occur during coordination that will be in effect for 2026 and impact UOCAVA voters. We can adjust the content of the printed guide until its print date in the late summer/early fall and can update the online information at any time. We will work with state election officials to get local election official contact information, but please do not hesitate to send us your individual updates to vote@fvap.gov.



# 2024 POST-ELECTION VOTING SURVEY (PEVS-SEO)

FVAP had begun fielding its survey, the State Election Officials Post-Election Voting Survey. This survey focuses on how state election official use FVAP products and services, interact with local election officials, and address UOCAVA-specific state ballot and registration policies. We then use the information from this survey to better support you in the future to assist our UOCAVA voters. The survey began fielding on January 8,2025. ## **UOCAVA TRAINING FOR ELECTION OFFICE STAFF**



# **Q&A: Common Question From Election Officials**



Q: When processing an FPCA, how do I validate a voter? Is the attestation of the individual when using the FPCA sufficient?

A: State law is ultimately your guide for this question. While UOCAVA does prohibit asking for ID, it is up to the states to administer the election process. If you have any questions, reach out to your state election office for further guidance on what other options are allowed or required as additional resources for validating voters.
